There are 230,000 DACA recipients residing in California. On September 5, 2017 President Trump ordered an end to the Deferred Action for Childhood Arrivals (DACA) program. The final submission date for application renewals for DACA recipients whose permits expire between September 5, 2017 and March 5, 2018 is October 5, 2017. On September 5, 2017 President Trump ordered an end to the Deferred Action for Childhood Arrivals program. No first-time applications submitted after this date will be processed. The final submission date for application renewals for DACA recipients whose permits expire between September 5, 2017 and March 5, 2018 is October 5, 2017. CELA encourages all eligible DACA renewal recipients to submit their paperwork on time. All DACA statuses and work permits will remain valid until their expiration dates.
