MID-YEAR KINDERGARTEN REGISTRATION

The Pacifica School District is pleased to offer the mid-year kindergarten program. To be eligible to attend mid-year kindergarten, students must have reached the age of 5 on or before January 31, 2009*. Students attending the mid-year program will attend kindergarten in the fall. Mid-year kindergarten is a morning program and will be held at the Linda Mar Educational Center.

HOW TO ENROLL

- Pick up an enrollment packet at the District or school office or call (650) 738-6606
- Registration will begin on November 2nd. Return forms to the **Pacifica School District Office** at 375 Reina del Mar Avenue in Pacifica. Registration hours are from 8:30 AM – 4:00 PM, Monday – Friday. The office will be closed November 23 – 27.
- Bring your child's **original birth certificate** and **current immunization record** and required proof of residency. **Registration will not be complete without these documents.**
- Students will be enrolled in the order in which their registrations are received. Should it be necessary to establish a waiting list, students will also be listed in the order in which their registrations are received.
- **Please register by Friday, December 11, 2009.**

KINDERGARTEN IN FALL 2010

Your child will attend Kindergarten in the fall. Although your child is enrolled in the mid-year program, parents must remember to register for Kindergarten that begins in fall 2010. Request the 2010/2011 Kindergarten enrollment packet from any K-5, K-8 school or the District Office. IMMUNIZATION REQUIREMENTS

POLIO	4 doses -- 3 doses meet requirement if at least one dose was given on or after the 4 th birthday
DPT	5 doses -- 4 doses meet requirement if at least one dose was given on or after the 4 th birthday
HEPATITIS B	3 doses
MEASLES, MUMPS, RUBELLA (MMR)	-- 2 doses of measles and at least one dose of mumps and rubella. Usually both given as MMR.
Varicella	1 dose -- at any age, or proof of disease (doctor's verification)
TB	(recommended)

*For attendance accounting, students turning 5 years of age after January 6, 2010 will be considered pre-school until their 5th birthday
