9.b. Presentation: Sunset Ridge, Campaign for Business and Education Excellence (CBEE)Honor Roll Recipient (7:15 p.m.)

Minutes:

Dr. Tukloff indicated the Campaign for Business & Education Excellence (CBEE) announced in early June an impressive number of

higher-performing public schools across California that included Sunset Ridge. Sunset Ridge is a part of CBEE's Honor Roll, a list of higher-performing, high-poverty schools whose students' achievement outpaced comparable schools. The 2014 Honor Roll includes public K-8 and high schools that are recognized for demonstrating consistently high levels of student academic achievement, improvement in achievement over time, and reduction in achievement gaps.

Dr. Tukloff presented Ellie Cundiff, Principal of Sunset Ridge with a certificate honoring their achievement.

10.e. Board/Superintendent Communications

Board members discussed events and activities they attended and participated in since the last Board meeting including: Vallemar, Ortega, Sunset Ridge, Ocean Shore, Vallemar & IBL Back-to-School Nights; Welcome to Pacifica School District event held at Vallemar School; Joint Study Session Between Pacifica School District and Jefferson Union High School District - Parcel Tax Survey Results; and, the LMEC Back-to-School Morning.

Ms. Villalobos wanted to know if teachers are still teaching Cursive Writing. She also shared that she is interested in the Advisory Program at IBL and Restorative Justice coming to us from Oakland.

Ms. Shiokari shared she was able to pay a site visit to Ocean Shore. During that time visiting the school with Ms. Gnusti, they were approached by some 8th Grade Ambassadors who were checking to see if they had any questions. In questioning these ambassadors in regards to what they liked about school and if there was anything that they needed, the ambassadors indicated no, they did not need anything and went on to share that they were very appreciative of the additional Chromebooks and technology provided them by the District over the summer!

Ms. Shiokari also wanted to share her feeling of concern for all of

our neighbors up North, in particular those devastated by the Valley Fire. She also reflected on our district's reserves, and what does a district do in times of trouble if they do not have good reserves.

Mr. Levie shared he was happy, when attending Vallemar's Back-to-School Night, to have the opportunity to apologize to Ms. Saxon for her not being able to stay late enough at the 8/26/15 Board meeting to share her excitement and enthusiasm for the Next Generation Science experience she will be participating in with the Lawrence Hall of Science.

Dr. Tukloff shared information regarding the Safe Schools gathering at the San Mateo County Office of Education that she attended.

11. DISTRICT BUSINESS - 7:45 P.M.

11.a. 2015 Parcel Tax Renewal Survey Results (7:45 p.m.)

Minutes:

Dr. Tukloff indicated Godbe Research and TBWB Strategies were contracted to gather public opinion in relation to a potential parcel tax renewal. Pacifica School District and Jefferson Union High School District (JUHSD) were able to partner on the survey. It was completed and the results were presented at a Joint Work Study held on Tuesday, September 8, 2015.

Dr. Tukloff introduced Bryan Godbe, Godbe Research and Sarah Stern-Benoit, TBWB who provided the Board with a presentation focused primarily on interpreting the results of the Parcel Tax survey for the District, followed by assisting the District in developing next steps. Their Power Point presentation can be found attached to this Board Agenda Item on the District's website.

The survey revealed a very solid base of voter support for both parcel tax measures, either together with JUHSD on the same ballot, or individually on separate ballots. Godbe Research & TBWB recommended the District go with placing their measure on the June 2016 ballot, and suggested that process, if it is the direction of the Board, should be started immediately. Following discussion of next steps, the District would be required to make their final decision by no later than March 11, 2016 to place a measure on the June 2016 ballot. For the November 2016 election, the deadline to submit the resolution to the County is in August of 2016.

Mr. Levie shared that it is a much heavier "lift" to raise the money for a November 2016 campaign. He also shared if the districts split and one goes in June and one in November, that in essence monopolizes the 2016 ballot for local issues, and there may be other groups that would also like to get into the mix and run a campaign that would do some good for our community, such as a library bond for a new library.

11.b. Ocean Shore Roof (8:00 p.m.)

Minutes:

Ms. Peterson thanked Mr. Hashizume who was in the audience to lend support to this discussion. She shared with the Board that staff has received a proposal from Allana Buick & Bers (ABB), an architectural/engineering consulting firm to investigate and evaluate the current roof and make recommendations on resolving the Ocean Shore Roof leak issue. ABB specializes in water intrusion issues and has a local and national reputation for resolving difficult issues. They propose to do an investigation, develop a solution, and prepare the document for the District to use in bidding the remediation work. Staff feels the professional advice from an independent architectural consultant is necessary to ensure an objective evaluation of the issue, one not influenced by a particular manufacturer, and where there is reasonable legal recourse should there be any defects or non-performance issues going forward. The contract will be brought to the Board on the Consent Agenda 10/7/15.

11.c. BP 5145.11 - Questioning and Apprehension by Law Enforcement (8:10 p.m.)

Minutes:

On August 26, 2015 BP 5145.11 was reviewed by the Board of Trustees. Included in the discussion were the issues of: when a parent is to be notified that an officer is requesting to interview a student on campus; the role and responsibilities of the school official during the process; and training, practices, and authority of law enforcement. Captain Joe Spanheimer of the Pacifica Police Dept. was present to provide input to the discussion.

Dr. Avila indicated, based on Board discussion on August 26th, staff revised the Board Policy and it was presented to the Board for review at this meeting.

Dr. Avila introduced Kathy Meola, Chief Deputy County Counsel, who was present to answer questions from the Board.

Ms. Meola suggested, based on comments by Mr. Levie, that she might possibly work with Dr. Avila in drafting an Administrative Regulation to include language regarding what school officials should be telling students in an interview situation with law enforcement.

Mr. Levie recapped, following Board discussion, the following section should be removed:

"When school officials feel the investigation becomes a custodial situation, the officer should have advised the student of their Miranda Rights/rights to remain silent and the principal or designee shall attempt to notify the student's parent/guardian but will not impede the actions of law enforcement."

With that section removed, BP 5145.11 would be ready to be brought back for approval on Consent October 7, 2015.

Mr. Levie continued to recap that the Board suggested a committee be

formed to develop an Administrative Regulation to accompany BP 5145.11 that might consider strengthening the language surrounding parent notification. The committee would include two Board members (Ms. Villalobos and Ms. Shiokari), Dr. Avila, and Ms. Meola.
