Board members discussed events and activities they attended and participated in since the last Board meeting: Graduations, Walk Through the American Revolution, District Office potluck, Sandy Ramirez's retirement party, the Measure D Election Results Night event, PEF-a thon Run, Cabrillo's Book Battle (teams 6-8 grade); visit to the Cabrillo library; and Sunset Ridge performance. Trustee Shiokari also took a moment to thank Karen Gnusti for her five years of service at Ocean Shore School.

Dr. Tukloff shared the Measure D-Parcel Tax passed with a resounding percentage. Dr Tukloff thanked the community and the Campaign Committee for helping move the agenda forward. Along with this year PSD will have 11 years of support from our community that will help to keep our program strong.

Dr. Tukloff highlighted summer options with June 16<sup>th</sup> being the last day of school. PSD is partnering with our Pacifica libraries/Summer Learning Program. They have been out to all of the schools and handed out reading materials, encouraging family trips to the library and to fill out reading logs, there will be prizes given for those that have participated.

Dr. Tukloff stated that a message was sent out, by Tina Van Raaphorst, regarding CAASPP results coming out this summer. This is the second time our students experienced this assessment. The data will be reviewed to see where we've made progress and areas for improvement. It will be a couple of more years however, before PSD and families will be able to use the data to determine trends/needs.

### Minutes:

Mr. Levie presented the Superintendent's contract for Dr. Tukloff. Highlights included that the severance requirement has gone down from 18 months to 12 months, should we terminate the contract early and that is per California law; no change in salary with the exception that Dr. Tukloff receives whatever raise LSMA receives; and that Dr. Tukloff does not receive medical benefits and that is also noted in the contract.

Mr. Levie contextualized the contract as it is the public's money and the Trustees want to be sure the money is well spent. He shared Dr. Tukloff's salary is comparable to other districts' in the County. He also provided a way to look at the school district as a 30 million

dollar corporation (PSD budget for the year). One way to look at a CEO's salary is to compare the CEO's salary to the median salary or the lowest paid employee salary. If you take the ratio of Dr. Tukloff's salary to that of a first year teacher it is 4.8 and if you take the salary of a median employee it is 3.25. In almost any organization, other than a school district, that would be a breathtakingly low figure for somebody with the training and leadership we expect.

Comments from other Trustees were in support of the contract and the work of the Superintendent.

# 5.b. Special Education Update Presentation (Goal: LCAP #7) (7:25)

#### Minutes:

Presentation: Special Education Update Dr. Ray Avila and Ms. Jennifer Grey. Dr. Avila introduced several special education staff members attending in the audience.

Highlights of the presentation included: The special education program built upon inclusive practices; information regarding the special education programs in Pacifica School District; the Linda Mar Educational Center (LMEC) special education preschool program that will have one class move to Sunset Ridge to continue support of ensuring inclusive opportunities by partnering with the City of Pacifica preschool; the two RSP models- the traditional model where the RSP teacher has a caseload of up to 28 students, and the intensive intervention model- where students can have this support up to three periods a day at a 1:14 ratio (currently at IBL Middle School); the development of a mental health plan to be supported by a mental health counselor funded 90% SELPA funds and 10% District base funds; San Mateo County classes housed within the district; Extended School Year (ESY) -a special education summer school program to prevent regression; special education personnel and support options for our employees.

Board comments included support for expanding the social-emotional focus and the importance of ensuring students with special needs feel a part of the school and classroom.
